



2019-2020 Keep North Carolina Beautiful Litter Prevention, Recycling and Beautification Grant Program

Purpose:

Keep North Carolina Beautiful (KNCB) established the Litter Prevention, Recycling and Beautification Grant Program to help support our local affiliates and to fulfill our mission to engage and support these organizations in order to Keep North Carolina Beautiful. We work with these organizations to offer hands-on community improvement projects that promote the cleanliness and sustainability of their community environments.

Eligibility:

Priority consideration for grants will be provided to active KAB affiliates within North Carolina. Funding may also be considered for entities in the active process of obtaining certification as a Keep America Beautiful Affiliate.

Funding:

Keep North Carolina Beautiful shall award grants of \$500 for projects in each of these three categories:

- **Beautification**

The purpose of these grants is to support beautification efforts within North Carolina's communities. Grants will be awarded to affiliate organizations in North Carolina who implement or expand projects or programs that beautify, clean, and benefit the community.

- **Litter Prevention**

Grants will be awarded to affiliate organizations that implement or expand programs in North Carolina to reduce litter. Funding will support waste reduction, litter prevention and cleanup events. The purpose of these grants is to support prevention and a measurable reduction of litter in North Carolina.

- **Recycling**

The purpose of these grants is to promote waste reduction and a measurable increase in reuse and recycling. Grants will be awarded to affiliate organizations that implement or expand programs to reduce waste and increase recycling in North Carolina. Funding will support educational outreach and recycling events.
